1. These Terms and Conditions (hereinafter: *Terms*) establish the rights, obligations, and responsibilities of the Adventure Park operator Seikluspark OÜ (registry code: 11227787) and the visitor (hereinafter: *Client*) when using the adventure courses (hereinafter: *Course*).
2. These Terms apply to all Clients using the Course.
3. Seikluspark OÜ has the right to refuse access to a person whose condition and/or abilities do not, in their opinion, allow safe use of the Course.
4. The Client is aware that use of the Course may damage clothing or personal belongings and may be dangerous to life and health if instructions, safety requirements, and these Terms (hereinafter jointly: *Requirements*) are not strictly followed. The Course is used at the Client's own risk. Seikluspark OÜ is not liable for any damage (including to health or property) caused by failure to follow these Requirements and/or negligence.
5. If a Seikluspark OÜ employee accompanies the Client on the Course, the employee has only an advisory role. The Course is still used at the Client's own risk. In such cases, the adult remains responsible for ensuring the safety of any minors accompanying them.
6. The Client may not use the Course before receiving instructions and safety equipment from Seikluspark OÜ staff. Before use, the Client must ensure that the selected Course matches their physical abilities, health condition, and skills.
7. Use of the Course while under the influence of alcohol, narcotic or psychotropic substances is prohibited. The consumption of such substances, smoking, and making fire on the premises are also prohibited.
8. The Client must pay for use of the Course in accordance with the valid price list of Seikluspark OÜ before starting.
9. While using the Course, the Client must follow all Requirements, instructions/orders from Seikluspark OÜ staff, and all signage and markings on the Course.
10. Use of the Course without being secured to the safety system is strictly prohibited and dangerous to life and health.
11. Safety equipment may not be transferred to another person and must be returned immediately after use. The Client must use the Course and equipment carefully and must compensate Seikluspark OÜ for any damage caused due to negligence or intentional actions.
12. A Seikluspark OÜ employee has the right to immediately remove the Client from the Course if the Client violates the Requirements or Terms, does not follow instructions, or if continued use is deemed unsafe. The Client must leave the Course immediately if they feel unwell or if weather conditions become unsafe. In such cases, the fee is not refunded.
13. Seikluspark OÜ is not responsible for loss, damage, or destruction of the Client's clothing or other belongings.
14. The fee paid to Seikluspark OÜ is refunded only if the Course cannot be used due to reasons attributable to Seikluspark OÜ.
